2022 Report and Accounts

Parochial Church Council of St Peter's Church, Thurston

Aim and Purposes

St. Peter's Parochial Church Council (PCC) takes pleasure in its responsibility of cooperating with the Rev'd Benjamin Edwards. The members look forward to continuing to promote, in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelical, social and ecumenical. The PCC cooperates with the PCC of Holy Innocents, Great Barton, within the Benefice of Great Barton and Thurston to share resources and fellowship.

Objectives and Activities

The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community at St Peter's. The PCC maintains an overview of worship and makes suggestions on how our services can involve the many groups that live within our parish. Our services and worship put faith into practice through prayer and scripture, music and sacrament.

When planning our activities for the year, we have considered the Commission's guidance on public benefit and, in particular, the supplementary guidance on charities for the advancement of religion. In particular, we try to enable ordinary people to live out their faith as part of our parish community through:

- Worship and prayer; learning about the gospel; and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- Missionary and outreach work.

To facilitate these objectives, it is important that we maintain the fabric of the Church of St. Peter and we work closely with the Thurston Ecclesiastical Charity in the use of "The Rock" church building.

Reflections from the Reverend Benjamin Edwards

This year we have embraced change, that scariest of words in the church! We have made various changes to the way that we worship, our mission to our communities and most notably, and sadly,

the change from praying for our Queen to our King: May she rest in peace and rise in glory.

So lots of change spoken about in this briefer report, but we also made stable the roots of our church past in ensuring that the Book of Common Prayer services of Holy Communion and Evensong continue as part of the worshipping life of the benefice.

Worship

The Remembrance-tide services in both churches were well attended, with large crowds gathering at Thurston by the memorial, and most poignant as we remembered the life and service of Her Majesty the Queen Elizabeth II.

It was a joy to be able to engage in a full Christmas service programme, with both schools enjoying excellent Christingle services, as well as the Scouts Association in Thurston, and to host the 863rd Air Training Corps for their Christmas Carol Service at St Peter's. Again, MY particular thanks to the churchwardens and helpers who cleaned up after we had a snow machine for the Crib services! Two different but excellent Christmas tree 'festivals' – Holy Innocents 'A Quiet Place for Christmas' was of course very quietly successful; I know that there are many who appreciated the opportunity to get away from Xmas hustle and bustle.

St Peter's Church was once again lit up in all respects – mention must go to Richard Fawcett who is stepping down from the festival this year; we thank him for his expert wiring and of course organising those participating in St Peter's and the library.

Due to some demand, we have reverted to a pattern of holding Benefice services in each church, with the addition of Together Family Church, first in both Great Barton and Thurston, and latterly just Thurston. We found the Great Barton endeavour to be poorly attended, despite advertising, and so have laid this aside for the time being. It may be that we consider Messy Church later this year for Great Barton, subject to volunteers.

BCP Holy Communion services moved to 08.30, to make this more manageable for this vicar's family life, relieving pressure on my day off (Saturday). It has made a difference, both to the fullness of my day off and to my energy levels on Sunday afternoons. I'd like to thank those who received the change with good grace and understanding.

Easter has been a mixed bag in terms of worship. Holy Week is the most important Christian festival of all, and especially the 'Triduum' of services on Maundy Thursday, Good Friday and Easter Sunday.

We had services across these three days, with the Walk of Witness in conjunction with Freedom Church included. Maundy Thursday, including the washing of the feet, was not well attended; the Good Friday Walk of Witness again saw a handful of congregation members' support, and the Hour at the Cross, a very powerful and moving service, attracted a handful of congregants.

I am very grateful for the presence of those who came to these services and events, particularly the Walk of Witness which was our first ecumenical event for quite some time, as I understand it.

Aside from the hard work that goes in to the Holy Week services, not just from me but from other lay leaders and from the choir, our faith culminates around the events that are commemorated in the Holy Week liturgies, and the small number of folk attending the services is worrying.

It is appreciated that Easter is also a time for families to get together, particularly after recent times of isolation due to Covid, and that Covid has been resurgent in the area too. Perhaps these are factors. We shall review the timing of these services for 2024 to allow more people to attend.

Easter Sunday, however, felt like the community rallied around – Holy Innocents had a good number in attendance, and at St Peter's the church was full of the buzz of children as the Together Family Church Easter service attracted some 23 children and 35 adults to join in with hot cross buns, songs, activities, Easter egg smashing and an Easter egg hunt. The highlight for me was the congregation gathered around the altar as we shared a simple Communion together, with homemade bread. It felt like the Kingdom breaking through.

Our musical tradition continues to stay steady – much thanks to our choir, to organist Chris Bartrop and to Bridget Read. We're very much looking forward to both recruiting for additional choir members to join now that we have an established pattern of worship, and promoting the upcoming Coronation service with the 'Sing for King' initiative, based upon the Royal Society of Church Music specially commissioned hymn.

We have been blessed by some excellent sermons from Kathy Drakes, our Reader-in-Training (to be licensed this September) and from our ordinand on placement, Dr Karen Smith.

Finally, mention must go to not only our church wardens for their hard work in ensuring worship happens, but also our retired clergy Reverend David Crawley and Reverend Mark Hunt, who have made themselves available for various worship and occasional office duties which is an enormous help to me personally.

Ministry & Mission

Our ministry to the wider community has been consistent, and we look to building upon that ministry as we begin to make plans to upgrade areas in the church buildings to reflect a commitment to the 'Growing Younger' part of our three point plan of focusing on Youth and Family, Deepening Prayer Life and Modelling Eco Approaches.

In focusing on youth and family, I will continue the good relationships I have with both primary schools as governor and leading collective worship weekly. Having a continued presence in the schools has been helpful in attracting more families to consider attending Together Family Church, bring their children to baptism and support the church in seasonal services.

The beginning of a relationship with the Sixth Form campus of Thurston Community College has begun, as I took an A Level philosophy class to examine the 'Problem of Evil', and I hope to be invited to further assist the College in this way.

We also look to fundraising for the upgrading of our children's areas, with both children's 'corners' needing updating, and the inclusion of a space for older children/young adults, with resources aimed at the younger generation.

Meeting Point continues to serve folk in Great Barton, moving to a weekly meeting.

And whilst primarily a fundraising event, the Gala Evening for the Windows appeal was a huge success, very enjoyable and a wonderful way to bring the village together for a common cause and we are now enjoying its benefits in the refurbished windows. I know the originator of the idea is quite humble in their acceptance of plaudits, as are her confederates in the matter, but with a committee of very thorough planners, Annie Wallace's wonderful idea turned into a BIG wonderful idea, and we are all very grateful for the hard work that the entire committee put in.

Many more ideas for mission and ministry are in embryonic form – look out for Church Explained, which is another opportunity to examine modern parables in the return of Dis-Course, and a seekers course, 'Being With', hopefully to come over the next year.

Endings, beginnings and thanks

Firstly, I wish to thank wholeheartedly Pat Sadler, Irene Churchus, Tim Frost and Angie Pearce for their enormous support to me in the first eighteen months of ministry. We also say goodbye to Irene Churchus' time as churchwarden of St Peter's at this APCM. Irene's warmth and positive attitude were a boon to me when I became vicar here, and her presence in this role will be sorely missed.

We also say goodbye to Mary Fawcett, who is stepping down from both PCC and Safeguarding. She has been involved since 1986, serving as churchwarden for many years and a member of the Ecclesiastical Charity since at least 1995. More recently, as you know, she has made an excellent job of the safeguarding responsibility which is a significant role these days and she is always willing to step in and help with services such as Together Family Church, to help clean, etc. I know Mary has said that, despite stepping down from the PCC, she will continue to help with events, which we're very grateful for.

We have as a benefice joined the Inclusive Church national family of churches – an organisation that helps signpost folk who may not find a welcome elsewhere to our churches, especially LGBT+ folk, differently abled, from any racial heritage, neurodiverse etc. We have seen first hand just how quick some churches are to turn their backs on their own Church just at the suggestion of welcoming LGBT+ folk, for instance, so our being a visible light to all those who may not find a

warm welcome to their local church is good, right, courageous and Christlike. I am absolutely brimming over with pride at how our churches engaged with the issue of universal welcome to ALL God's children, talked sensibly about it and then voted unanimously to join Inclusive Church, whose guidance will help form us into the sort of churches that we want those moving to our ever-growing villages to find. For the long-term future of the benefice, this puts us streets ahead and I hope that all will seek to embrace our journey to becoming a church known for its considered and holistic welcome to ALL.

We say a goodbye to Together Church in Great Barton for the time being, as we lay it aside and take time to reflect and rethink how we might offer ourselves to the families and children in Great Barton.

Huge thanks again goes to the assistance with administration from Peter Robinson, who often also acts as my back-up diary for when things get misplaced in my mind! Thank you Peter for putting up with the frustration of being my admin assistant – I hope our triumphs outweigh my less glorious efforts!

We sadly said goodbye to faithful Christians from our communities- to Alf Nightingale, former churchwarden of St Peter's, and to Marie Bass, member of Holy Innocents and the community who reside in Montana Care Home. May they rest in peace, and rise in glory.

And something to look forward to – the licensing this year of Kathy Drakes as Reader; we have already benefitted from her wisdom in sermons and assistance with courses on prayer – it will be excellent to work alongside Kathy as we seek to deepen our prayerful lives as a Christian community; Kathy has been instrumental in starting and developing our 'prayer chain'.

Final Note

So much has been achieved, so much promises to begin to blossom in the year ahead, and new buds forming all the time as we tend to that which grows in our communities. We are beginning to shine, to cast a light over the patches of our villages that suffer from gloominess. We will, as we go, uncover more. The rootedness and depth of those who have faithfully attended the churches for decades is the bedrock upon which we continue to build these churches – the good earth from which we all grow. That good earth has been enriched by those who grow in and alongside it, and eventually, bit by bit, pruning by pruning, season by season, our churches will be a vibrant garden that all of those in our communities will be happy to walk in – they may even stay long enough to cast roots into that rich soil themselves!

Please continue to support our churches – with your presence above all else; your prayerful presence is the greatest gift of all as we give thanks to God for our Saviour Jesus Christ and the ongoing work of the Holy Spirit through us and with us and in us. Amen

Achievements & Performance compiled by the Churchwardens

The past year, like the previous one, was a challenging time for our church and our lifestyle, as we still tried to overcome the effects of Covid. Exercising care, we were able to return to something like normal as we began to share the cup and welcomed old friends and new ones to our services. We sang joyously, prayed for people and tragedies around the world, and opened our doors to all people, irrespective of race, gender, disability or other need.

We continue to work with our Benefice Church, Holy Innocents at Great Barton, to provide a regular pattern of services to include Holy Communion, Book of Common Prayer and Common Worship, as well as Sung Eucharist. This year Reverend Ben has done much work to connect with young families and to this end a monthly, 'Together Family Church' has been held at Thurston Primary Academy. Most recently, on Mothering Sunday and Easter Sunday, this group worshipped in our church, where several families enjoyed a fun packed morning of crafts and singing, and an informal communion with homemade bread.

Over the past year, five couples were married at St Peter's and four children baptised there and this brought happiness and laughter into our church. We also held funerals and interment of ashes services, and heard stories of lives lived and memories shared.

During 2022 we welcomed many young people into our church for special services. Thurston Primary Academy held their regular services at Easter, Harvest and Christmas, although their Christingle service had to be conducted at school, due to icy weather conditions. The Scouting Association joined us for Remembrance Sunday and then for their Christingle service in December. Through Reverend Ben we renewed our association with the Air Training Corps Cadets, and a Carol Service for them took place near Christmas.

Other memorable events were held throughout the year. The Queen's Platinum Jubilee service took place in June to celebrate 70 years of Her Majesty, Queen Elizabeth II being on the throne. In September we invited the community through our doors to sign the book of condolence on the sad occasion of Her Majesty's death. The Christmas Tree Festival weekend was a great success and on the Saturday evening we were entertained by the Thurston and Elmswell Ladies Voices choir. Fundraising was uppermost in our minds during the year and a plan of action was discussed and will carry forward following our APCM in 2023. We organised our usual 'Gift Day,' which was generously supported by members of our church and the wider community. We held coffee mornings and our Christmas Bazaar as always, raised much-needed funds for our church.

Our new churchyard was used for the first time with several burials taking place. A plan for future 'Green Burials' and 'A Garden of Remembrance' has been formulated. We are thankful to the

village Tree Officer for acquiring and planting hedging around the boundary of the new churchyard and to those who have offered to help cut the grass. This is very much a work in progress.

As always there are many people to thank for their invaluable support. There is a long list, and we apologise if we miss anyone out. We thank, the band of church cleaners who turnout every week, whatever the weather; the flower arrangers who add beauty to the altar and throughout our church on special festivals; to those who open and close our doors every day; to the gentleman who just turns up to tidy our churchyard; to those who read lessons, prepare intercessions, welcome people to services, and serve at the altar; to those who provide coffee; to our guest organists, in the absence of a permanent organist; to our choir who sing so dutifully; to our bell ringers who keep the tradition alive and to Barbara who offers a listening ear for those in need of prayer.

We also thank our Parochial Church Council, our treasurer Gillian, our secretary Vicky, and Peter, for helping out with all things technical.

Thank you one and all, your help and assistance is greatly appreciated.

We look forward to what 2023 will bring and welcome new offers of help. We are here if you want to get in touch and would like a chat.

On a personal note, I would like to say a big thank you to Irene who is stepping down as churchwarden after faithfully serving in office for ten years. I know only too well how much time Irene has put in, and she has more than fulfilled her duty.

She and I have shared many experiences over the years, from clearing what seemed like a huge area of the churchyard to locate a grave, to taking down the remains of cupboards, to repairing numerous items and to organising people and events. Carpenter, electrician, locksmith, florist, cleaner, general dogsbody and peacemaker, Irene has done it all.

Her answer to most things was to spray it with WD-40. I was the sceptic, but nine times out of ten it worked, hence she became known as the Queen of WD-40.

Irene will also be remembered for being instrumental in obtaining our new churchyard. It was a passing remark she made, to Muriel Myatt, that set the wheels in motion to the church being gifted the land from Edward and Muriel.

Irene: we will definitely stay in touch, but enjoy your retirement; you deserve it.

Electoral Roll

At the end of December 2022, there were 64 on the Church Electoral Roll.

Deanery Synod

Two members of the PCC currently sit on the Deanery Synod. This provides the PCC with an important link between the parish and the wider structures of the church.

Building

The building is Grade II listed since 15 November 1954 and its English Heritage Building ID is 281245. It is medieval, but virtually rebuilt in 1861 by J H Hakewell following the collapse of the medieval tower onto the nave. The chancel was restored in the mid 19th Century.

The roof alarm system continues to work well and there have been no call outs in 2021. All electrical inspections are up to date. The first burials have taken place in the new churchyard and the hedging around it is now planted.

Financial Review

This has been another challenging year financially but we ended the year with our budget showing a small surplus to carry forward to our plan for 2023.

We are extremely grateful to all those who continued to make donations through the Parish Giving Scheme, regular standing orders, weekly envelopes at services and the Gift Day. Despite continuing difficulties this year, these donations, and the Gift Aid they generated (plus a grant from the Thurston Ecclesiastical Charity of £12,848) totalled £ £43,651, which was around £5000 more than was received in donations last year. This is largely due to the generosity of the Charity and we are very grateful to them.

We thank all those who helped with the organisation of our fundraising events and those who supported them. This enabled us to raise £3375, which is some £500 more than in 2021. The 2022 Christmas profits and will appear in the 2023 accounts as they were received in January.

During 2022 we were able to meet the Parish Share requirements from the Diocesan Board of Finance.

Once again we were not able to add to our reserves in 2022. However in line with our Reserves Policy, the amount in the undesignated general fund in the deposit account at year end still just equates to roughly two months' estimated running costs.

We are especially grateful to Gillian Bush who continues as our Treasurer.

Thurston Ecclesiastical Charity

The Charity is connected to St Peter's Church with Trustees being the Vicar, the Churchwardens and two additional members elected by the PCC, currently Mary Fawcett and Christopher Wells.

Income is applied for furthering the religious and other charitable purposes of the Church of England in the Ecclesiastical Parish of St Peter's, Thurston.

The Charity owns The Rock building, which provides excellent facilities for St Peter's. It gives a warm venue for coffee after the main services and is used regularly for Church meetings, informal worship, coffee mornings and activities run by the Mothers' Union. In addition the Charity owns the Church Field and the Cottage.

Structure, Governance and Management

The Parochial Church Council is a corporate body established by the Church of England and operates under the Parochial Church Council Powers Measure. The PCC is exempted by order from registering with the Charity Commission.

The method of appointment of PCC members is set out in the Church Representation Rules. At St. Peter's the membership of the PCC consists of the incumbent (our vicar, when we have one), churchwarden/s, currently two members of the Thingoe Deanery Synod and others elected by those members of the congregation who are on the electoral roll of the church. All those who attend our services and are members of the congregation are encouraged to register on the Electoral Roll and stand for election to the PCC.

The PCC members are responsible for making decisions on all matters of general concern and importance to the parish including deciding on how the funds of the PCC are to be spent.

During the year the St Peter's PCC met four times during the year, once in the church porch and the remainder in the church with ventilation, social distancing and masks under Covid regulations.

Administrative information

St. Peter's Church is situated on Church Road, Thurston. It is part of the Benefice of Great Barton and Thurston, within the Diocese of St. Edmundsbury and Ipswich of the Church of England.

Independent Examiner's Report to the members/trustees of St Peter's Church, Thurston Parochial Church Council

I report on the accounts of the Trust for the year ended 31 December 2022.

Respective responsibilities of Trustees and Independent Examiner
